- 5. To consider and act upon the following resolution:
- (a) to appropriate \$373,000 for costs related to environmental remediation due to oil spills at the School Complex and the Highway Garage, and related work, and costs related to the financing thereof. Such appropriation shall be in addition to a prior appropriation and borrowing authorization of \$540,000 approved at Special Town Meeting held March 4, 2015 and Referendum held March 17, 2015, for an aggregate appropriation of \$913,000;
- (b) to authorize the issue of bonds or notes in an amount not to exceed \$373,000, and temporary notes, to finance the increase in the appropriation for the project. The bonds or notes shall be issued pursuant to Section 7-369 of the General Statutes of Connecticut, Revision of 1958, as amended, and any other enabling acts. The bonds or notes shall be general obligations of the Town secured by the irrevocable pledge of the full faith and credit of the Town;
- (c) to take such action to allow temporary advances of available funds which the Town reasonably expects will be reimbursed from the proceeds of borrowings; and to authorize a majority of the Board of Selectmen and the Treasurer to bind the Town pursuant to such representations and covenants as they deem necessary or advisable in order to maintain the continued exemption from federal income taxation of interest on the bonds, notes or temporary notes authorized by the resolution if issued on a tax-exempt basis, including covenants to pay rebates of investment earnings to the United States in future years, and to make representations and enter into written agreements for the benefit of holders of the bonds or notes to provide secondary market disclosure information, which agreements may include such terms as they deem advisable or appropriate in order to comply with applicable laws or rules pertaining to the sale or purchase of such bonds, notes or temporary notes;

Pursuant to Section 7-7 of the General Statutes of Connecticut, Revision of 1958, as amended, and the resolution adopted at referendum held October 9, 1997 regarding the submission of non-budgetary appropriations to referendum, to adjourn said town meeting at its conclusion and to submit the resolutions to be presented under Items 5 to 8 of this Notice to vote upon voting machines, which vote, in the absence of objection, shall be held on Wednesday, May 25, 2016, between the hours of 12:00 p.m. (noon) and 8:00 p.m. Electors will vote at the following polling places:

District No. 1 — Thompson Hill Fire Department, 70 Chase Road, Thompson

District No. 2 — Town Office Building, 815 Riverside Drive, North Grosvenordale

District No. 3 — Quinebaug Fire Department, 720 Quinebaug Road, Quinebaug

Absentee ballots will be available from the Town Clerk's office.
