1. Conservation Officer Report
  - a. New Requests:
    - 1) The Director of Planning for the PZC requested a review of the Jared Meehan 4 lot subdivision on Hill Road. Carolyn Werge prepared the review and asked members via email for approval. It was forwarded on to PZC with no additional comments.
  - b. Old Requests: None
  - c. Updates:
    - 1) The Conservation Commission had 3 items to be resolved at the Town Meeting on October 28, 2015. Two of the items were not approved: the Conservation Ordinance and the two Open Space parcels associated with New Rd. The third item was approved: the five town owned open space parcels are now protected by Conservation Easements.
    - 2) Norma O'Leary and Carolyn Werge toured the three cemeteries recently cleaned of brush and overhanging branches: Bates, Porter and Quaddick Cemeteries.
      - i. Kathy Mitchell had asked about the legal access to Coman Cemetery at the last meeting. Carolyn Werge did some research but her findings were inconclusive. Mountain Hill Road may be the legal means of access.
    - 3) Ron Tillen is working on a project for the Wyndham Land Trust filling in gaps in documentation and resolving issues associated with WLT conservation easements. Carolyn Werge has been assisting on a volunteer basis.
