*Officer and Committee Reports*

1. Conservation Officer Report
  - a. New Requests
    - 1)The Conservation Commissions input was requested regarding a Declaratory Ruling Application #DEC15005 of the Thompson Trails Committee. The consensus of the Commission was to suggest that the fresh cut areas be top dressed with coarse wood chips to provide firm footing on the dirt path, particularly after rain events.
  - b. Old Requests: None.
  - c. As of October 1, 2014, new legislation in section 19a-308 regarding the liability of volunteers helping with maintenance work in cemeteries states no municipality or employee, officer or agent of a municipality shall be civilly or criminally liable for undertaking the care and maintenance of a burial ground or cemetery. Carolyn Werge will confirm this with the first selectman.
  - d. Selectman Paul Lenky spoke with Bill St. Onge about moving forward with preparing the Conservation Easements for the five open space parcels acquired in recent years.
  - e. The Conservation Commission Ordinance is supposed to move forward to a Town Meeting.

- f. A Town Meeting has not been scheduled in regards to the Land donation in East Thompson.
  - g. Cemeteries Project:
    - 1) Carolyn Werge presented the hard copy of the Cemeteries Inventory at the Board of Selectmen's meeting on February 3<sup>rd</sup> and delivered a copy to the library.
    - 2) Joe Lindley has sent a database file of his work alphabetizing the gravestone inscriptions from the Hale Collection of the entire town and assigning a cemetery code to each name.
    - 3) Another law that was put into effect October 1, 2014 found in section 19a-308b establishes an account municipalities are able to apply for to be used on neglected cemeteries.
  - h. The letter to the Editor was published in the Thompson Villager regarding the Bluebird Nest Box Project. So far 28 nest boxes have been distributed.
  - i. Carolyn Werge digitized the boundaries of the Tamler Property, Wyndham Land Trust's newest acquisition, and added it to the map of all the Wyndham Land Trust property conserved in the town.

- 3. Kathy Mitchell asked for the advice of the commission regarding the Environmental Quality Incentives Program.


