A) Call to Order & Roll Call.

Meeting was called to order by Chair Fran Morano at 7:22 PM.

B) Action on Minutes of Previous Meeting:

Motion to accept the minutes of the April 14, 2015 meeting with amendments to D.a.1 statutory receipt date from 2/10/15 to 3/10/15, D.a.1,2&3 Janet's last name from Lavallee to Blanchette and the correct spelling of 'proposed' was made by Commissioner Tillen. Seconded by Commissioner Obert. Motion passed unanimously.

- D) Pending Applications:
  - a) Permits:
    - 1) **IWA15008** Town of Thompson, Reardon Rd, Assessors Map 65, Block 100, repair of Reardon Rd replacing about 110' of earthen embankment with stone, stamped received by Town Clerk on 4/10/15, statutory receipt date 4/14/15.

Motion to approve permit IWA15008 was made by Commissioner Obert. Seconded by Commissioner Tillen. Motion passed unanimously.

2) **SUB15007** Lavallee Construction LLC, 0 Fabyan Woodstock Rd., Assessors Map 5, Block 86, Lot 7, 4 lot subdivision, received by Wetlands Office on 3/4/15, statutory receipt date 4/14/15. Jason Lavallee was present to explain the subdivision, answer questions and to request a waiver of fee's from \$1060.00 to \$310.00 due to the minimal amount of wetland issues.

Motion to approve permit SUB15007 was made by Commissioner Obert. Seconded by Commissioner Tillen. Motion passed unanimously.

Motion to waive any additional fees above \$310.00 for SUB15007 was made by Commissioner Tillen. Seconded by Commissioner Ricard. Motion passed unanimously.

  - 1) WAA15010, Lavallee Construction, LLC, 75 Church Street (for the Justice Resource Institute), Assessors Map 67, Block 102, Lot 9G, construction of a temporary access road within 100-feet of a mapped wetland to provide access for the construction of a gymnasium that is not located in a regulated area, stamped received by Wetlands Office on 4/21/15, approval issued 4/21/15, Legal notice was published on 5/8/15, the appeal period to IWC ends 5/22/15. Ms. Butts put a condition on Approval WAA15010 when issued that the landscaping material that was previously dumped north of the stone wall between flags WAF9 & WF5A be removed and a berm established to prevent dumping in the future and to correct an outstanding violation.
