IV. Citizen's Comments Pertaining to Agenda Items

1. Steve Herbert informed the Commission that there is \$75,000 included in the proposed Town budget to be voted on at Referendum for an Economic Development Commissioner/Director (title to be determined). It was initially suggested by a member of the audience at a Board of Finance meeting, and it was seconded by some BOF members and opposed by others. The position would be a full-time basis, but is only funded for part of they Fiscal Year 2016-2017 so the position would not start July 1, 2016. H. C. Obert suggested that the EDC is in a position to write the job description for that position. J. Sharpe clarified that the idea at the BOF meeting was to bring in someone to Thompson like Delpha Very who works for Putnam, to start moving Thompson forward and enticing business and growth. The Commission briefly discussed ideas to begin writing a job description.
2. Steve Herbert also stated that he spoke to Dan Julian at the Industrial Park to ask if he would come to speak to the EDC at a meeting. The Commission discussed the proposed sewer/water connection for the Industrial Park, as well as future traffic possibilities to and from the Industrial Park.
