BUCKELY HILL ROAD RECLAIMIG & REPAVING PROJECT

Syl Pauley, Jr., a registered professional engineer of the State of Connecticut who works with NECCOG, presented the results of his evaluation of the five bids that were submitted. He read his letter into the record. These bids were opened at 4:00 p.m., on August 27, 2010 at the Special Selectmen's Meeting. The lowest bid was received from B & W Paving and Landscaping LLC for \$249,264.11. He reviewed the documentation, equipment and references. The timeline and requirements of this project were reviewed.
