- Mr. Babbitt commented that he has attended meetings with the Department of Public Safety in regard to the Quinebaug Firehouse project.

## SELECTMEN'S BUDGET PROPOSAL FOR FY 2008 DISCUSSION

Mr. Babbitt explained that he added this agenda item to give Mr. Groh an opportunity to discuss the budget. Mr. Groh responded that because he had not attended the meetings that he was going to hold any comments in regard to the budget.

Ms. Hiatt explained that there was one position in Town that the Board had agreed to cut three hours from a position at the Town Hall. Ms. Hiatt explained that the position serves two different offices and would like to add back an hour to one of the offices.

*Motion made by Ms. Hiatt, seconded by Mr. Babbitt, to amend the budget submission to the Board of Finance to include a two-hour cut to the position in question as opposed to a three-hour cut.*

- Mr. Landry reported that the Renewable Energy Committee visited a geothermal site and also visited Staples to see the largest photovoltaic setup in New England.

- Mr. Landry questioned why there is not an award for fathers during the Springtime Festival.
- A concerned citizen commented that a simple way to save money and conserve energy would be to shut off all of the computer equipment at the school each night.

- Ms. Hiatt stated that Norman Rudzinski commented at the last meeting in regard to carbon monoxide from the generator at the School. Ms. Hiatt stated that she spoke to David Johnson and that he said they have a procedure when they are working on the school that there are workmen in the trailer that will investigate and shut down the generators when a concern is brought to their attention.
  - Mr. DeVivo expressed his concern in regard to the gas station on Riverside Drive. Mr. DeVivo also asked if the Board addressed his issue with the Zoning Enforcement Officer. Mr. DeVivo also presented photographs of how the property at the gas station looked before the convenience store / Dunkin Donuts was put in. Mr. DeVivo also presented photographs of the fence at the gas station. Mr. DeVivo expressed concerns of the water that is being shed on his property from the gas station property. Mr. Babbitt stated that Representative Johnston, the Attorney General's Office and the DEP are all involved in resolving this issue. A lengthy discussion followed.
