  - a. New Request: None

  - c. Board of Selectmen
    - 1) First Selectman Paul Lenky is still waiting for a written response from Attorney St. Onge on the liability issue for cemetery volunteers.
    - 2) Carolyn Werge has been in contact with Attorney St. Onge in reference to the Conservation Commission Ordinance language; we are now waiting for a status report from the attorney.
    - 3) The meeting of Bernie Davis, Phil Thomas and Carolyn Werge with First Selectman Paul Lenky in regards to the Conservation website is being rescheduled.
  - d. Audrey Witkowski has been hired as the new recording secretary.
  - e. Amy Coman-Hoenig has been reappointed; her term will expire March 14, 2019.
  - f. Land donation in East Thompson
    - 1) This donation involves two pieces of property – one off of Starr Road and one off of New Road.
    - 2) A site walk with the owner Allan Rawson will be held soon.
