 - Kerstin Forrester told the members that she will be going to Hartford to respond to the complaint filed by Mr. Paul Baer against the her, the Committee, and the Town because minutes for November and December meetings were posted a week late.  - Hogan asked about requirements for posting minutes and agendas on the Fire

 - Discussed Hogan's email with recommendations on how to create public awareness of the need for the town to finance the FDs.
 - Write a collective letter to the public that focuses on "who we are and what we
 do"; current funding levels, the cost of OSHA requirements, (personal protection
 gear, tires, etc); and how the suggested organization would function.
 - Suggested that we ask the local papers to report on emergency calls by Fire Department each week, i.e. fires, accident assistance, etc.
 - Suggested that we work with the Villager to write features about each Fire Department during the next two months, including photos and interviews. Kerstin will talk to Jason Bleu
 - Consider setting up a Facebook page for each Fire Department
 - Ask WINY to do interviews with the Chiefs

- Community Day participation:
 - Set up a table and each FD will have representatives
 - Get a big map outlining each FD area Kerstin will check with someone at town hall to get help with this
 - Include house numbers on map so people will know which FD covers them
 - Each FD will put together data # of call last year or YTD, # of volunteers at each FD, a list of requirements for training and time for training, and OSHA requirements.
 - Create a "Do you know" card regarding training
